At the initial stage the activities of the Institute were classified into different core programmes rather than individual subject/discipline based units. During the XIth Plan the Institute reoriented its activities as Development Research Institute to initiate more stakeholder need based studies.</p> <p>The Institute is poised to take a leading role in the development of Himalayan region in the XIIth Plan period. The institute would aim at increasing the internal integration and Institutional collaborations, and building its own competence. For the purpose of strengthening this process, entering into MoUs for collaborative research would be adopted. The Institute will focus on institutionalization (both process and partnership) of research projects by creating appropriate models (design) which emanates as knowledge products with well framed mechanism for partnership along with methods/steps for implementation and information dissemination.
