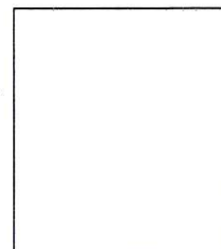
1. Aspiring candidates satisfying the eligibility criteria may walk-in on 16.08.2024 at 10:00 AM.
